Dates for seasons are tentative and change each year depending on weather and climate.

Suspension of burn permits can still allow special projects to occur if conditions are met and there is considerable advanced planning with CAL FIRE. Exceptions likely only for underburning.

CAL FIRE can declare a Burn Ban during any season in which no permits can be issued. CAL FIRE permits only apply if you live in the State Responsibility Area. Local RAs may have different policies. Burning in American and Thompson Valleys can be conducted by NSAQMD permit only from Nov. 15 through Mar. 15 each year. Burning is prohibited year round in the Portola City limits, Quincy, and East Quincy. Both CAL FIRE and NSAQMD can declare "no burn days" on any day due to air quality, wind, temperature, relative humidity, etc. If concerned or unclear on whether or not you can burn on a certain day, contact the agency representatives above.
